Account terms and charges		
Monthly service fee	\$99	Waive this monthly service fee by maintaining an average monthly collected balance of \$100,000 or more in your Premier Checking account(s). Monthly cycle service charges will be assessed beginning on the fifth statement cycle from account opening or following the date of conversion for converted accounts. If an account fails to enroll in Business Premier Checking Treasury Management Services, a monthly cycle service charge up to \$25 may apply. Contact your Business Banker for additional details.
Additional checking accounts	First 5 free, \$25 monthly service charge per account after	Up to 5 Premier Checking accounts may be linked at no additional charge. Any Premier Checking accounts in excess of 5 will incur a \$25 monthly service charge per account.
Earns rewards	No	This account does not earn rewards.
Pays interest	No	This account does not earn interest.
Online banking	Free	There is no charge for online banking with this account.
Online bill pay	Free for select options	There are no charges to use online bill pay with this account and no fees for select bill pay payment methods, such as payments by ACH. Fees apply for other payment methods, such as payments by credit card.
